Mrs. Shiffer thanked Mrs. DeGuzman for creating Zones of Regulation posters for students and staff to utilize. January's character trait is grit. Current enrollment is 222.

Athletic Director's Report – Mr. Ahearne presented the Athletic report. Varsity Boys Basketball is currently undefeated. The Varsity Girls Basketball team is down to six players, but working hard to complete the season. There will be a wrestling tournament held at the school January 20th and 21st.

Middle School / High School Principal's Report -- Mr. Ahearne presented the report. Mr. Ahearne thanked those that attended the recent High School play. Thanks to local business for silent auction donations. The drama program raised \$1,300. Kristen Eagle will be addressing MS/HS staff at upcoming staff meeting to help implement the zones of regulation at the middle school level. There will be a pep assembly for winter sports on January 26th. The inaugural Pizza War will take place that afternoon as well. Exams will take place January 18th-20th. Current enrollment is 260.

Superintendent's Report – Mr. Taylor presented the report. Mr. Taylor is working on the budget revision and hopes to have it ready for board review shortly. The budget revision is based on solid information after June 30, 2022, when the initial budget is due. Mr. Taylor welcomed Mrs. Mitchell to the board. The Mio Athletic Boosters have donated \$300 towards the purchase of a mascot outfit for athletic events in hopes of raising the level of school spirit. Mr. Taylor will be attending the Mid-Winter Superintendents Conference January 18-20.
